These checks are made in accordance with the Code of Practice for the Pastoral Care of International Students and results are available on request.
- For students under the age of 18 not staying in a homestay assigned by Fern / NZMA, quarterly visits must be undertaken at a cost of \$50 to the student or their family.
- Students must agree to abide by the rules of the homestay agents, host family and school.
- While attending high school, students must stay in homestay accommodation and not own a motor vehicle.
- Where a student decides to terminate the homestay accommodation, notice of two weeks must be given.
- Our homestay agents will endeavour to keep all students safe at all times but cannot be held liable for personal injury or loss of life.
- All students must be medically insured.

2010 Fees are **\$210 per week** with a **placement fee of \$273**. One week's accommodation is seven days and seven nights. The minimum initial stay is four weeks. Additional fees apply for holding of rooms and extra care (guardianship of students under the age of 18). Accommodation fees refunds are available provided sufficient notice is given.
